"It shall be the duty of clergymen, magistrates, and other persons who perform the marriage ceremony in the City of New York to keep a registry of the marriages performed by them, * * * " (Sec. 34, Sanitary Code).

"Every person authorized by law to perform the marriage ceremony shall, * * * register his or her name and address in the office of the Bureau of Records of the Department of Health." (Sec. 35, Sanitary Code.)

"It shall be the duty of every person required to make or keep a registry of * * * marriages * * * to present to the Bureau of Records of the Department of Health a copy of such registry signed by such person, within ten days after the * * * marriage * * *, which copy of such registry shall thereupon be placed on file in the said Bureau." (Sec. 33, Sanitary Code.)
